

The Local Government Ombudsman's Annual Letter Mansfield District Council for the year ended 31 March 2007

The Local Government Ombudsman (LGO) investigates complaints by members of the public who consider that they have been caused injustice through administrative fault by local authorities and certain other bodies. The LGO also uses the findings from investigation work to help authorities provide better public services through initiatives such as special reports, training and annual letters.

Annual Letter 2006/07 - Introduction

This annual letter provides a summary of the complaints we have received about your authority. Where possible, we comment on the authority's performance and complaint-handling arrangements to assist with your service improvement.

I hope that the letter will be a useful addition to other information your authority holds on how people experience or perceive your services.

Two attachments form an integral part of this letter: statistical data covering a three year period and a note to help the interpretation of the statistics.

Complaints received

Volume

In year ending 31 March 2007, I receive 25 complaints about your Council. This is higher than last year by seven, but with a relatively small number of complaints no meaningful conclusions can be drawn from this.

Character

I have summarised the profile of the types of complaint showing last year's figures in brackets.

As you can see the most significant rise has been in the number of complaints about planning matters. These accounted for almost half of all the complaints I received about your Council. The Council can draw some comfort from the fact that my investigations have not identified systemic problems in the way the Council administers its planning services but you may to reflect on what moved people to complain.

Decisions on complaints

Reports and local settlements

A 'local settlement' is a complaint that is resolved by the Council taking, or agreeing to take, action which we consider is a satisfactory response to the complaint so that the investigation can be discontinued. In 2006/07 27.7% of complaints dealt with by the three Local Government Ombudsmen (excluding premature and those outside jurisdiction) were resolved by local settlement. When we complete an investigation we must issue a report.

Decisions

In 2006/07 I determined 21 complaints, a figure which differs from the number of complaints received because of work in hand at the start and finish of the year.

Of those 21 decisions: two were outside my jurisdiction, two I exercised discretion not to investigate, in seven I found no evidence of maladministration and nine were 'premature' (in our view the Council had not been given adequate opportunity to investigate and resolve them for itself, so were returned to the Council to consider through its internal complaint procedure).

The remaining decision was a local settlement. I did not issue any reports against your council and overall did not find issues that gave significant concern or that were indicative of systemic problems in the way the Council administers its services.

Other findings

As you are aware, we ask for comprehensive responses to our enquiries within 28 days. I am pleased to say your Council responded in 26.5 days on average and am grateful to your Council for its cooperation in this respect.

Your Council's complaints procedure and handling of complaints

My investigations of and dealings with your Council have revealed no issues with the way in which you handle complaints. The information you publish about your complaint procedures is clear and readily accessible. I am pleased also to note that it contains direct reference and links to the LGO.

Training in complaint handling

Part of our role is to provide advice and guidance about good administrative practice. We offer training courses for all levels of local authority staff in complaints handling and investigation. The feedback from councils that have taken up the training is very positive.

The range of courses is expanding in response to demand and in addition to the generic Good Complaint Handing (identifying and processing complaints) and Effective Complaint Handling (investigation and resolution), we can run open courses for groups of staff from smaller authorities and also customise courses to meet your Council's specific requirements.

All courses are presented by an experienced investigator so participants benefit from their knowledge and expertise of complaint handling.

I have enclosed some information on the full range of courses available together with contact details for enquiries and any further bookings.

Liaison with the Local Government Ombudsman

We have experienced no problems with the liaison arrangements your Council has in place. The staff appointed by the Council to co-ordinate and send responses to our requests for information are helpful and professional.

LGO developments

You may be interested in the development of our initiative to improve the first contact that people have with us. A new Access and Advice Service will provide a gateway to our services for all complainants and enquirers. It will encourage telephone contact but will also deal with email, text and letter correspondence. We will let you have further details about how it will operate and the expected timescales and discuss with you the implications for the Council.

I hope you have received our latest special report about telecommunications masts. It draws on our experience of dealing with complaints about planning applications for masts which can be highly controversial. We recommend simple measures that councils can adopt to minimise the chances of maladministration occurring.

In July we will be publishing a special report about the difficulties that can be encountered with complaints when local authorities deliver services or discharge their functions through partnerships. *Local partnerships and citizen* redress provides advice and guidance on how these problems can be overcome by good governance arrangements that include an effective complaints protocol.

Conclusions and general observations

I welcome this opportunity to comment on our experience of complaints about the Council over the past year. I hope that you find the information and assessment provided useful when seeking improvements to your Council's services.
