The Local Government Ombudsman's Annual Letter

Broadland District Council

for the year ended 31 March 2008

The Local Government Ombudsman (LGO) provides a free, independent and impartial service. We consider complaints about the administrative actions of councils and some other authorities. We cannot question what a council has done simply because someone does not agree with it. If we find something has gone wrong, such as poor service, service failure, delay or bad advice, and that a person has suffered as a result, the Ombudsmen aim to get it put right by recommending a suitable remedy. The LGO also uses the findings from investigation work to help authorities provide better public services through initiatives such as special reports, training and annual letters.

Annual Letter 2007/08 - Introduction

This annual letter provides a summary of the complaints we have received about Broadland District Council. We have included comments on the authority's performance and complaint-handling arrangements, where possible, so they can assist with your service improvement.

I hope that the letter will be a useful addition to other information your authority holds on how people experience or perceive your services.

Two attachments form an integral part of this letter: statistical data covering a three year period and a note to help the interpretation of the statistics.

Complaints received

Volume

We received 11 complaints against your Council this year half the number received in 2006-2007 (22). This is an encouraging trend, although we expect to see fluctuations year on year, and such small numbers can easily be distorted by several complaints about the same issue.

Character

Nine complaints were received about planning and building control matters and one each about benefits and housing.

Decisions on complaints

Reports and local settlements

When we complete an investigation we issue a report. I issued no reports against your Council this year.

A 'local settlement' is a complaint where, during the course of our investigation, the Council has agreed to take some action which we consider is a satisfactory response to the complaint. The investigation is then discontinued. In 2007/08 the Local Government Ombudsmen determined some 27% of complaints by local settlement (excluding 'premature' complaints - where councils have not had a proper chance to deal with them - and those outside our jurisdiction).

Two complaints were settled locally this year. In a housing allocations complaint the Council accepted that that its appeal panel had not taken account of all relevant matters relating to the complainant's housing register banding and offered a fresh appeal.

A complaint was made to me about a delegated planning decision. The applicant's agent was an employee of the Council and this meant that the planning application should have been determined by Elected Members. The Council had recognised its error before the complaint came to my attention and had referred the matter to Committee which confirmed that the decision to grant planning permission was acceptable. The Council also offered the complainant £250 for his time and trouble. I am pleased to note the Council's prompt and appropriate response to this complaint.

Other findings

Fourteen complaints were decided during the year. Of these three were outside my jurisdiction for a variety of reasons. One complaint was premature and was referred back to your Council for its consideration through the complaints process. The remaining eight were not pursued because no evidence of maladministration was seen or because it was decided that no significant injustice flowed from the fault alleged.

Your Council's complaints procedure and handling of complaints

The single complaint referred back to the Council represents approximately 7% of all the decisions made and this is significantly less than the national average, which this year is 27%. This supports the view that your complaints process is readily accessible to the Council's residents and that staff continue to signpost the process effectively.

Liaison with the Local Government Ombudsman

We made enquiries on four complaints this year and the average time for responding was 26 days. That is within our response time target of 28 days. It also represents an improvement on last year's average response time of 27.2 days. This is the third year running that the Council has met this target and I congratulate it on its performance in this area.

Training in complaint handling

Part of our role is to provide advice and guidance about good administrative practice. We offer training courses for all levels of local authority staff in complaints handling and investigation. This year we carried out a detailed evaluation of the training with councils that have been trained over the past three years. The results are very positive.

The range of courses is expanding in response to demand. In addition to the generic Good Complaint Handling (identifying and processing complaints) and Effective Complaint Handling (investigation and resolution), we can run open courses for groups of staff from different smaller authorities and also customise courses to meet your Council's specific requirements.

All courses are presented by an experienced investigator so participants benefit from their knowledge and expertise of complaint handling.

I have enclosed some information on the full range of courses available together with contact details for enquiries and any further bookings.

LGO developments

We launched the LGO Advice Team in April, providing a first contact service for all enquirers and new complainants. Demand for the service has been high. Our team of advisers, trained to provide comprehensive information and advice, have dealt with many thousands of calls since the service started

The team handles complaints submitted by telephone, email or text, as well as in writing. This new power to accept complaints other than in writing was one of the provisions of the Local Government and Public Involvement in Health Act, which also came into force in April. Our experience of implementing other provisions in the Act, such as complaints about service failure and apparent maladministration, is being kept under review and will be subject to further discussion. Any feedback from your Council would be welcome.

Last year we published two special reports providing advice and guidance on 'applications for prior approval of telecommunications masts' and 'citizen redress in local partnerships'. I would appreciate your feedback on these, particularly on any complaints protocols put in place as part of the overall governance arrangements for partnerships your Council has set up.

Conclusions and general observations

I welcome this opportunity to give you my reflections about the complaints my office has dealt with over the past year. I hope that you find the information and assessment provided useful when seeking improvements to your Council's services.
