

**The Local Government Ombudsman's
Annual Letter
South Bucks District Council
for the year ended
31 March 2008**

The Local Government Ombudsman (LGO) provides a free, independent and impartial service. We consider complaints about the administrative actions of councils and some other authorities. We cannot question what a council has done simply because someone does not agree with it. If we find something has gone wrong, such as poor service, service failure, delay or bad advice, and that a person has suffered as a result, the Ombudsmen aim to get it put right by recommending a suitable remedy. The LGO also uses the findings from investigation work to help authorities provide better public services through initiatives such as special reports, training and annual letters.

Annual Letter 2007/08 - Introduction

This annual letter provides a summary of the complaints we have received about the South Bucks District Council. We have included comments on the authority's performance and complaint-handling arrangements, where possible, so they can assist with your service improvement.

I hope that the letter will be a useful addition to other information your authority holds on how people experience or perceive your services.

Two attachments form an integral part of this letter: statistical data covering a three year period and a note to help the interpretation of the statistics.

Complaints received

Volume and character

As was the case last year we received just a handful of complaints against South Bucks District Council this year - four complaints as opposed to five received in 2006/07. These were spread across four different category areas – the administration of benefits; housing; planning and building control; and local taxation.

Decisions on complaints

Reports and local settlements

A 'local settlement' is a complaint where, during the course of our investigation, the Council has agreed to take some action which we consider is a satisfactory response to the complaint. The investigation is then discontinued. In 2007/08 the Local Government Ombudsmen determined 27% of complaints by local settlement (excluding 'premature' complaints - where councils have not had a proper chance to deal with them - and those outside our jurisdiction).

In 2007/08 the Local Government Ombudsmen decided four complaints made against the Council. None of the complaints we investigated this year justified the issue of a report or a local settlement, as I found no evidence of fault in one complaint, insufficient evidence of injustice in one other, and the remaining two complaints concerned issues which were outside my jurisdiction. This maintains the outcome of the preceding two years where complaints to me were small in number, and I found no evidence of fault in those which I considered.

Your Council's complaints procedure and handling of complaints

I did not refer any complaints back to the Council last year as "premature". The national average for the number of complaints I referred back to councils because they have not had a sufficient opportunity to respond to them was 27%.

Taken together with the small number of complaints which have been made to me in recent years, this may reflect well on the Council's own service delivery as well as its ability to resolve concerns when things go wrong. I would however be grateful for the Council's own observations on this, as well as some information about the number of complaints it deals with through its own corporate complaints procedure, and the stage which they reach before they are resolved.

Liaison with the Local Government Ombudsman

The target time for councils to respond to enquiries is 28 days. The average response time for your Council is 13.5 days, which is a very good performance as well as being an improvement on last year's average of 20 days.

Training in complaint handling

Part of our role is to provide advice and guidance about good administrative practice. We offer training courses for all levels of local authority staff in complaints handling and investigation. This year we carried out a detailed evaluation of the training with councils that have been trained over the past three years. The results are very positive.

The range of courses is expanding in response to demand. In addition to the generic Good Complaint Handling (identifying and processing complaints) and Effective Complaint Handling (investigation and resolution) we now offer these courses specifically for social services staff and a course on reviewing complaints for social care review panel members. We can run open courses for groups of staff from different smaller authorities and also customise courses to meet your Council's specific requirements.

All courses are presented by an experienced investigator so participants benefit from their knowledge and expertise of complaint handling.

I have enclosed some information on the full range of courses available together with contact details for enquiries and any further bookings.

LGO developments

We launched the LGO Advice Team in April, providing a first contact service for all enquirers and new complainants. Demand for the service has been high. Our team of advisers, trained to provide comprehensive information and advice, has dealt with many thousands of calls since the service started.

The team handles complaints submitted by telephone, email or text, as well as in writing. This new power to accept complaints other than in writing was one of the provisions of the Local Government and Public Involvement in Health Act, which also came into force in April. Our experience of implementing other provisions in the Act, such as complaints about service failure and apparent maladministration, is being kept under review and will be subject to further discussion. Any feedback from your Council would be welcome.

Last year we published two special reports providing advice and guidance on 'applications for prior approval of telecommunications masts' and 'citizen redress in local partnerships'. Again, I would appreciate your feedback on these, particularly on any complaints protocols put in place as part of the overall governance arrangements for partnerships your Council has set up.

Conclusions and general observations

I welcome this opportunity to give you my reflections about the complaints my office has dealt with over the past year. I hope that you find the information and assessment provided useful when seeking improvements to your Council's services.
